2019 HIGHLIGHTS

In April the Scituate Board of Selectmen voted unanimously to award the Contract to build Phase I of the Scituate Dog Park to *Green Acres Landscape & Construction* for \$282,723. Funding for the contract came from the *Stanton Foundation* (\$225,000), the *Scituate CPC* (\$48,700) and a donation from the Friends of Scituate Dog Park (\$29,499.07). The FOSDP also donated the water service installations thanks, in part, to *Ted Ringler* of *Ringler Excavating Corporation* who provided his services as a donation to our non-profit.

MARK YOUR TERRITORY

Our "Mark Your Territory" Brick Fundraising campaign was launched in the spring and by the end of the year had raised over \$11,000! Donors can order custom inscribed bricks to be installed at the park walkway in spring 2020.

ST. PATRICK'S DAY PARADE

A hearty group marched in the St. Patrick's Day Parade to raise awareness for the park and the dogs that participated were a crowd favorite!

SCITUATE 5-K9 ROAD RACE

In May, the First Annual Scituate 5K9 road race took place and was a huge success. Over 100 people participated – running, walking, and hand-cycling to the finish. In addition, 30 dogs joined their two-legged companions! This great event was organized by Rachel Naclerio and her team of volunteers. We thank them for all of their hard work in managing race logistics, securing local sponsors and of course, selecting the FOSDP as the beneficiary of the net profits.

SCITUATE DOG PARK OPENS!

September 28th marked the Grand Opening of the Scituate Dog Park. This Phase I of construction included a 1 acre fenced in area for all dogs with facilities installed for our Phase II small dog area. Dozens of people and pups came out to celebrate with us and be the first to pass through the gates as "Who let the dogs out?!" played courtesy of DJ Andrew Boyle. Senator Patrick O'Connor and State Representative Patrick Kearney were on hand to help cut the ribbon and surprised the FOSDP with a Citation of Recognition. We sold custom "Scit.Stay.Play." tee-shirts, Donna Culbert of Donna's Do Right Dogs had a "giveaway" table, Maura Devine was selling her Reece's Homemade Doggie Treats, we served coffee and donuts. and met lots of new friends!

A beautifully crafted custom Donor Board was installed at the park entrance thanks to Matt and Shelley Swanson of BirchBarn Designs.



The Scituate Dog Park is open to the public every day from dawn to dusk.

The park provides a safe and secure area for supervised dogs to run, play, walk, sniff, socialize and explore...with offleash freedom. Amenities such as sitting benches, bag stations, drink and wash fountains and trash barrels are there for all to use. Park Rules, educational banners and other park information is posted for the benefit of all visitors.

FOSDP began 2019 with net assets of \$24,717.64. We received \$56,890.70 in cash and amenity donations. Expenses, which included \$29,499.07 for the park construction, totaled \$39,982.97.

*FOSDP is a registered 501(3)c non-profit organization.


